Kimmo Kiljunen visits Moldova, urging parliamentary dialogue

Kimmo Kiljunen, Head of the PA's Parliamentary Team on Moldova, visited Chisinau and Tiraspol on 12-14 June. Mr. Kiljunen's visit was aimed at supporting constructive dialogue regarding a Transdniestria settlement through improved parliamentary co-operation and developing a common draft resolution on Moldova for the upcoming Session in Brussels.

Mr. Kiljunen met with the Speaker of the Moldovan Parliament, Marian Lupu, the Head of the Moldovan Delegation to the OSCE PA, Sergiu Stati, and the leadership of other parliamentary factions. In Tiraspol, Mr. Kiljunen met with the Speaker of the Transdniestrian Supreme Soviet, Evgeni Shevchuk, and the deputy chief negotiator, Ruslan Slobodeniuk, as well as representatives of media and civil society.

On behalf of the OSCE PA Team on Moldova, Mr. Kiljunen expressed concern about the lack of progress in the negotiations on the settlement of the status of the Transdniestrian region. He expressed the team's hope that "improved dialogue at the parliamentary level will provide the necessary political climate to support the negotiations on the status of the Transdniestria region" and expedite the conflict settlement.

The visit was organized with the assistance of the OSCE Mission to Moldova. From the International Secretariat, the Team was accompanied by Programme Officer Anna Chernova.

PA Secretary General meets with OSCE Ambassadors

On 15 June Secretary General Spencer Oliver travelled to Vienna to hold meetings with a number of Ambassadors to the OSCE Permanent Council. The visit was organized primarily to discuss issues with regard to the upcoming Annual Session, particularly concerning the Assembly's election observation activities.

Mr. Oliver met with the Ambassador of the Belgian OSCE Chairmanship, the Ambassadors of Spain (upcoming OSCE Chairmanship in 2007), Finland (upcoming OSCE Chairmanship in 2008), Austria (EU Chairmanship), Denmark, and the Russian Federation. The meetings were organized by Ambassador Andreas Nothelle from the PA Liaison Office in Vienna.
